



## **COVID Policies Update North Coast Gymnastics**

August 23<sup>rd</sup>, 2021

### **Staff and Athlete/Participant Updates:**

**Per updated State Mandate August 23<sup>rd</sup>, Masks are required for all with the EXEMPTIONS below, per state mandate:**

All Staff who are fully vaccinated and past the two-week mark may choose to ACTIVELY coach without a mask on. (Verified by NCGA, and Included in Exemption from State Mandate)

Entry/Exit of Facilities- All Participants aged 5 and older: Masks ARE required for entry and exit and while not actively participating in class (Per state mandate)

Participants over the age of 5: Masks are NOT required for athletes while they are actively participating in class/team trainings. (Included in Exemption from State Mandate)

Participants under age 5: Participants Under age 5 are NOT required to wear face coverings, unless under the direct supervision of a parent/guardian (per State Mandate)

If you or your child is sick in any way, PLEASE STAY HOME. If you have a confirmed/possible covid exposes, please notify us immediately.

SELF SCREEN AT HOME: if a child is dropped off with any cold/flu/covid symptoms they will be promptly isolated and need to be picked up within 15 minutes. Please make sure you continue to self-screen as you all have been doing.

Continued care is being taken regarding extra cleanings and increased air flow through our facilities.

### **Non-Staff or Non-Athlete/Participant Updates:**

**Parent Viewing: Masks are REQUIRED for all non-participants AGE 5 AND OLDER, REGARDLESS of vaccination status.** We appreciate all non-staff or non-participants, parents, grandparents, guardians, etc. help with keeping everyone safe. (Per State Mandate)
